
- b) To establish, maintain, run, develop, improve, extend, grant donations for and to aid, assist in the establishment, maintenance, running, development, improvement and extension of general commercial and technical education, elementary schools, secondary schools, high schools, higher secondary schools, Colleges, libraries, reading rooms, laboratories, research and other institutions.
- c) To establish, develop, maintain and grant aid in cash or in kind to hospitals, medical schools, medical colleges, nursing institutions in India for the benefit and use of the general public.
- d) To promote, establish, support, maintain or grant aid to institutions for the promotion of science, literature, music, drama and fine arts, for the preservation of historical monuments and for the research and other institutions, in India, having similar objects for the benefit of the public in general.
- e) To establish, maintain or grant aid for the establishment and/or maintenance of parks, gardens, gymnasiums, sports clubs, dharmashalas and rest houses, for use by public in general.
- f) To establish, maintain or grant aid to homes for the aged, orphanages or other establishments for the relief and help to the poor, needy and destitute people, orphans, widows and aged persons.
- g) To establish and develop institutions for the physically handicapped and disabled or mentally retarded persons and to provide them education, food, clothing or other help.



- o) To promote, assist and/or maintain all activities by whosoever carried on or wherever carried on in India in conformity with the objects of the Trust and as are conducive to the well being and general welfare of the nation or are conducive for advancement of any object or objects of general public utility not involving/carrying on any activity for profit.
5. The income and funds of the Trust shall be solely utilised towards the objects specified in para 4 herein above and it shall not be utilised for the benefit of any person referred to in sub-section (3) of section 13 of the Income-Tax Act, 1961 and for payment to Trustees by way of profit, interest, dividend etc.,
6. The Trust and the Trust fund shall be irrevocable for all times.
7. Regular and correct accounts of the Trust, its funds, receipts and expenditure shall be maintained. The financial year of the Trust shall end on 31st March every year. The accounts of the Trust shall be audited by a qualified auditor.
8. a) The number of trustees shall be not less than THREE and not more than nine.
b) All the trustees unless they voluntarily resign or otherwise decide, shall continue to be the trustees during the term of their natural lives.
c) The Founder Trustee, namely, Mr. V. Govindasamy, shall have the right to nominate any one person as Trustee during his life time.

- d) On any vacancy occurring in the Board of Trustees by the death or by the resignation of a Trustee or any other cause, it shall be competent and lawful to appoint any person or persons in the place of the person or persons who had ceased to be Trustees. The power of appointment of Trustees shall be exercised by a resolution of the Board of Trustees of as the Founder Trustee decide.
- e) So long as any person belonging to the family of Founder Trustee is available and willing to be Trustee and suitable for the appointment of Trustee, the Trustees when Founder Trustee is not living, shall appoint only such persons. At all times the majority of the Trustees shall be the member of the family of Mr. V. Govindasamy, the Founder Trustee and no appointment shall be made so as to make the members of the family of Mr. V. Govindasamy, the Founder Trustee who are Trustees less than a majority of the Trustees.
- f) Any person appointed as Trustee in accordance with clause 8 (d) above shall hold the office for a period of five years from the date of their respective appointment or election, at the expiry of the said period shall vacate their office, but shall be eligible for a fresh election.
9. The Trustees shall not be entitled to any remuneration, but the Trustees may reimburse themselves all expenses actually incurred by them in connection with the trust or their duties relating there to.
10. a) The affairs of Trust shall be managed by the Board of Trustees of the said trust.

- b) The Board of Trustee shall consists of not less than Four and not more than nine, as the Board of Trustees shall time to time resolve.
- c) The Founder Trustee and four other trustees and every person who may hereafter appointed Trustees shall constitute the Board of Trustee.

- g) The Board of Trustee may exercrise all the powers vested in them under these presents or by law, by a resolution passed at meetings of the Board of Trustee by a majority of votes.
- h) In the event of equal division of votes, the president of the Board of Trustee shall have a casting vote in addition to his vote as Trustees.

- i) A resolution in writing circulated amongst all the Trustees and signed by majority of them shall be as valid and effectual as if it had been passed at a meeting of the Trustees duly called and convened.
- j) On any vacancy arising in the office of the Managing Trustee or president the successors to such office shall be filled in by election by the Board of Trustees.
- 11. That for the furtherance of the objects of the trust, the trustees shall have the following powers:
 - a) To accept any donation, contribution, grant or subscription in cash or in kind, from any person(s) body of persons or trust, with or without conditions.
 - b) To apply the whole or any part of the income of the trust or the trust fund or accumulations thereto to any one or more of the objects of the trust, as the trustees may, in their discretion, deem fit from time to time.
 - c) To convert and deal with the trust property and/or any investments for the time being.
 - d) To invest Trust fund either in the purchase or construction of immovable properties or to obtain immovable property by way of lease or of mortgage immovable property or in such manner as allowed by law as may be in force from time to time and to convert, alter, vary dispose of or transfer such investments from time to time.

- e) To borrow or raise or secure payments of moneys and also to lend money either with or without security.
- f) To sell, dispose of, alienate or otherwise deal with any property comprising the Trust Fund.
- g) To let out, demise any immovable property comprised in the Trust Fund for such period and at such rent on such terms and conditions as the Trustees in their discretion may think fit.
- h) To open account in the name of the Trust. Trustees and/or institutions run/conducted by the Trust with a Bank or Banks, or operate such account and to give instructions to the bank and to provide for opening and operation of such account by one or more of the Trustees or by an agent appointed by the Trustees.
- i) To adjust, settle, compromise, compound, refer to arbitration, all actions, suits, claims, demands and proceedings regarding the Trust Fund.
- j) To appoint constituted attorneys or agents and to delegate to such attorneys or agents all or any of the powers vested on them under these presents and from time to time remove such attorneys or agents and to appoint other or others in his or their place.

- k) To appoint or make provision for the appointment of any person (including all or any of the Trustees and committees or administrator or Managing Trustees or otherwise) for the purpose of the administration of the Trust in such manner and subject to such rules and regulation as the Trustee may prescribe and also to appoint or provide for the appointment of separate Trustees to hold any fund or investment subject to the provisions of this Deed in such manner and subject to such rules and regulations as the Trustees may from time to time think fit.
- l) To make, vary, alter or modify schemes, rules and regulations for carrying out the subjects of the Trust and for the management of the affairs there of and/or running any institution in furtherance of the objects of the Trust and otherwise for giving effect to the objects of the Trust.
- m) To start, abolish, discontinue and restart any charity or charitable institutions for the benefit of general public and to impose any conditions to any subscription or donation made by them.
- n) To set apart and/or allocate the whole or a part of the income of the objects of the Trust.
- o) To set apart join, co-operate or amalgamate this trust with other or others having kindred or allied objects, upon such terms and conditions as the trustees may in their discretion think fit particularly having regard to and in conformity with the objects and nature of this Trust.
- p) To give aid by way of donations out of the income or the corpus of the Trust Fund or otherwise, to different charitable institutions, societies, organisation or Trusts hereafter be established for the like charitable purposes mentioned in these presents or any of them to enable such institutions societies, organisation or Trustees to start maintain, or carry out such Charitable objects.
- q) To borrow moneys either on the security of any property comprised in the Trust Fund or otherwise for all or any of the purposes of these presents, and it shall be lawful for interest and otherwise on such terms and conditions as they may in their absolute discretion think fit.
- r) To apply to the Government, public bodies, urban, local, municipal, district and other bodies, corporation, companies or persons for and to accept grant of money and of aid, donations, gifts, subscriptions, and other assistance with a view to promoting the objects of the Trust and to discuss.

- s) To take over or amalgamate with any other charitable trust, society, association, or institution with similar objects.
 - t) To establish, promote, manage, organise or maintain or to assist in establishing, promoting, managing, organising, or maintaining any branch of the Trust or any other Trust or its branch with objects similar to those of this Trust and to promote or carry on the affiliation or amalgamation of such other Trust with this Trust.
 - u) To take over, acquire, manage, control or aid any existing institution or institutions having objects either wholly or in part similar to the objects of this Trust and on such terms and conditions as may be thought expedient.
 - v) To purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities and engagement of any or more of the trusts, societies, institutions or associations with which this Trust is authorised to amalgamate.
 - w) To transfer all or any part of the property, assets, liabilities and engagements of this Trust to any one or more of the Trust, societies, institutions or associations with which this Trust is authorised to amalgamate.
 - x) To transfer and hand over the Trust on dissolution to any other society, institution, trust or organisation having similar objects on such terms and conditions as the Trustees shall in their absolute discretion think fit and proper to be held by the society, Institution, Trust or Organisation with the powers, provisions, agreements and declarations, appearing and contained in these presents subject to such modifications as may be necessary and consequent to such transfer of the trust fund. The Trustees for the time being of these presents shall become discharged from the Trust hereof relating to Trust Funds so transferred.
12. If the income from the trust property in a particular year is not fully utilised, the unexpended income subject to the applicable provisions of the Income-Tax Act 1961, shall be carried over to the next years or it may be invested in accordance with the provisions of 13(1)(d) read with section 11(5) of Income-Tax Act, 1961 and spent in such subsequent year or years for the advancement of any of the object of the trust.
13. All the properties, assets and funds of the Trust shall vest and in be held in the name of the Founder Trustee, on behalf of the Trust and shall be held in such names only. The Board of Trustee shall not be entitled to vary alter or change the position and they may do so only on the demise of the Founder Trustee.





15. It is expressly declared that no part of the Trust property or its income or any accretion thereto shall be applied for any purpose outside India or for any purpose which is not a charitable purpose in law and all provisions hereof shall be constructed accordingly.
16. If any amendment is made to this trust deed, it must be intimated to the commissioner of Income-Tax and his objections. And suggestions are also to be incorporated in the Trust deed.


